#### Notes on System Price List:

- Estimates on this price list include installation, sales tax and **estimates** for City of Phoenix plan review and permit fees.
- More sizes and options available.
- Estimated adder for Tucson is \$1,300; for Flagstaff is \$1,800. Servicing utility solar program to dictate credit purchase payment if not APS or SRP.
- Savings based on average cost per kWh for typical utility residential rate schedule. Actual savings will vary depending on utility rate schedule and actual energy costs.
- SRP maximum rebate is \$60,000.
- Final estimates with detailed specifications and costs are provided after a site visit has been conducted at your property. Call 480-994-1440 to schedule your site visit.
- Modification to electrical equipment are not included in these estimates; system quotes will be provided after site visit for electrical upgrade work, if necessary.
- Customer receives credit purchase payment directly from utility after system is inspected and commissioned.
- APS and SRP funds must be reserved to guarantee availability.
- Customer responsible for completing appropriate tax documents in order to claim Arizona and Federal Personal Income Tax Credit.
- Prices and system specifications contained in this document are subject to change without notice.
- Federal Personal Income Tax Credit applies to systems placed in service AFTER December 31st, 2008.
- Estimated First Year kWh Generated: Data is for Phoenix, Arizona. PV performance is largely proportional to the amount of solar radiation received, which may vary from the long-term average by ±10% for yearly values. The values in the table assume that the PV array has an unobstructed view of the sky, a 25% average daily power de-rating and a fixed-pitch PV array due-south with a 30° tilt angle
- Estimated Twenty Year Cumulative Kilowatt-Hour (kWh) Generated: Based on typical major manufacturer PV module 20 year limited warranty on power output. Long term output warranty typically warrants if PV Module(s) exhibit power output of less than 90% of the the original minimum rated power specified at the time of sale within 10 years or less and less than 80% within 20 years after the date of sale to the Customer. Annual PV Module degradation rate estimated at 0.25%.
- Estimated Twenty Year Cost per Kilowatt-Hour (kWh) represents the estimated twenty year cumulative kWh generated divided by the installed price after incentives.
- All system performance is estimated and actual output may vary with site conditions. Please consult your tax advisor for applicability of tax incentives.
